IQ 2015 BUDGET STATEMENT

DOHA, QATAR - Industries Qatar (“IQ” or “the group”; QE: IQCD), one of the region’s industrial giants with interests in the production of a wide range of petrochemical, fertiliser and steel products, released a brief statement on the group's recently approved budget for 2015.

The group looks forward to 2015 and the anticipation of significantly improved sales volumes, despite the recent decision to stop production at Qatar Steel's EF-1 and -2 facilities until further notice, following the preventive maintenance and warranty shut-down program completed in 2014. These major planned shut-downs are an essential requirement for large, industrial facilities as they can help minimise unplanned disruption, ensure product quality is maintained and, ultimately, contribute to an extension of the plants’ production life, improved reliability, and a minimisation of the environmental impact. Consolidated earnings in 2015, however, are expected to be impacted by the effects of the prevailing economic conditions on international price levels of the group's key products, and an increase in fertiliser operating costs. Liquidity levels are expected to remain strong due to the muted capital expenditure program and relatively low debt.

Industries Qatar reiterates its commitment to openness and transparency, and confirms that in line with the company's disclosure practices, the Qatar Exchange will be informed if any material change in assumptions arises.

The business operations of the company comprise the direct holding of shares in the following subsidiary and joint venture companies: (i) Qatar Steel Company QSC ("QS"), a wholly-owned subsidiary, engaged in the manufacture and sale of steel billets and reinforcing bars; (ii) Qatar Petrochemical Company Limited QSC ("QAPCO"), a joint venture owned 80% by IQ, engaged in the production of ethylene, low-density polyethylene ("LDPE"), linear low-density polyethylene ("LLDPE") and sulphur; (iii) Qatar Fertiliser Company SAQ ("QAFCO"), a joint venture owned 75% by IQ, engaged in the manufacture of ammonia and urea; and (iv) Qatar Fuel Additives Company Limited QSC ("QAFAC"), a joint venture owned 50% by IQ, is engaged in the production of methanol and methyl-tertiary-butyl-ether ("MTBE").
